
Sir,

Your kind attention is invited to the subject cited above. The Council is pleased to inform you that the matter with regard to extension of MoU and grant of permission to start admission process for B.Ed.Spl.Ed - ODL programme for the academic session 2021-22 has been examined in light of the prevailing situation arose from the 2<sup>nd</sup> wave of COVID-19. Accordingly, conditional permission to start admission process for B.Ed.Spl.Ed. - ODL Programme for the academic session 2021-22 is hereby considered subject to the following conditions:

- I. University will ensure the availability of required infrastructure facilities and faculties throughout conduct of the programme as per the prescribed norms and standard of ODL programme of RCI. List of the faculty available for B.Ed.Spl.Ed.- ODL programme such as name, designation, academic and professional qualification, photograph, CRR No. etc. to be submitted to the Council.
- II. B.Ed. Spl.Ed.-ODL programme to be conducted only at those Institutes who fulfils the prescribed eligibility conditions to become Study Centre(s) as mentioned at para (i) & (ii) of 6.1 of Norms and Standards of ODL programme of RCI and No Objection Certificate (NOC) has been issued by the Council to these Study Centres.
- III. B.Ed. Spl.Ed.-ODL programme to be conducted at RCI's approved study centres only. Candidate enrolled at unapproved study centres for B.Ed.Spl.Ed.-ODL programme will not be accepted for registration in CRR under any circumstance. Prescribed intake for each study centre to be ensured and it should not be exceeded more than the prescribed intake.
- IV. Admission process to be commenced under intimation to the Council. Study Centre wise list of admitted candidates in B.Ed. Spl.Ed.-ODL programme during the academic session 2021-22 along with allocated intake to each centre to be submitted to the Council.
- V. It is requested that the inspection team to be contacted for immediate inspection once the normalcy is restored as it is essential for extension of MoU.
