- ii. Complete printed set of Self Learning Material (SLM) developed by the University in r/o B.Ed.Spl.Ed. ODL (HI,VI,ID, LD) course, as per RCI revised syllabus, 2015 to be submitted to the Council and Distance Education Bureau, UGC for vetting.
- iii. Disability area wise list of operational study centre to be furnished to the Council.
